Dog License Application Form

All dogs in township must be licensed annually to comply with state, county, & town regulations.
Noncompliance penalties: 1st offense: written warning; subsequent offenses: \$25—\$100 plus court costs.

\$4.00: Neutered Male or Spayed Female
\$9.00: Un-Neutered Male or Un-Spayed Female
\$35.00: Kennel (5—12 dogs; \$3.00 each additional dog)

- Submit a separate check and completed application.
- License your dog(s) every year. Return completed form by January 31.
- **Current Rabies vaccination certificate required;** a license cannot be issued without it.
- **Dog tags** will be mailed to you or may be picked-up at the Lincoln Town Hall during office hours in December & January.
